History

Port Dover is a town of approximately 6000 residents and is situated on the north shore of Lake Erie. Its history can be traced back to the early Jesuits who wintered there during the winter of 1669-1670. Port Dover's story began when settler Peter Walker wandered into this area in 1794. Walker Street is named in his honour.

Daniel McQueen is credited with being the first settler in what is now known as Port Dover. He built a home and mill dam where Ivey's Dam is today and before long was joined by others. This resulted in a prosperous settlement, which today is popularly referred to as Dover Mills. Rich in history Port Dover was attacked by American troops during the war of 1812 with only one house spared destruction. Settlers gradually rebuilt their lives about one mile away near Lake Erie's shore and Patterson's Creek, now known as the Lynn River.

A harbour, at the mouth of the Lynn River, was established around 1830 and lumber and grain was carried to ports along the Great Lakes. Eventually fishing boats moored along side the schooners and the industry developed and, at one point in time, Port Dover was home to the largest fresh water fishing fleet in the world. Even now, Port Dover is still synonymous with Lake Erie commercial fishing. The history of boat building along the Lynn River dates back to 1837 when the "Resolution" was launched. Elements of the industry are still in existence to this day.

The present town of Port Dover was laid out in 1853 by Israel W. Powell who set aside a market square in the main business area. Years later it was named in his honour...Powell Park. Port Dover was incorporated as a "village" in 1879 with its first village council headed by Reeve Thomas Gillies. Prior to that date this hamlet was part of the Township of Woodhouse. Port Dover became a "town" in 1954 headed by Mayor Harold Schneider.

On January 1, 2001 Port Dover became part of the new County of Norfolk.1

Background

In May of 2007 Norfolk County, through it's Planning and Economic Development Department, introduced the Community Improvement Plan². The document states that it was developed to establish a framework for Norfolk County's support and implementation of programs that may be utilized to encourage the maintenance, rehabilitation and redevelopment of the county. The plan further notes that it will provide the county with the authority to implement incentives and programs for the betterment of Norfolk County.

The Community Improvement Plan augurs well with the efforts of the Port Dover Enhancement Association because it identifies several goals that the Association will be pursuing in its efforts to improve Port Dover. In particular, it lists, as one of its goals to "Revitalize Downtown Areas While Recognizing Retail Trends and Community Needs". This goal provides the framework for a number of objectives that the Port Dover Enhancement Association's "Downtown Sub-committee" is proposing.

Further, the plan, through various Goals and Objectives listed on the same page, provides support for other Sub-committees of the Port Dover Enhancement Association.

As a result, the Association is encouraged by the Community Improvement Plan and will refer to it throughout our Strategic Plan as a key source document.

Mission Statement of the Port Dover Enhancement Association

To encourage the preservation and enhance the unique identity of Port Dover as the community develops including, but not limited to, Entranceways, Downtown, Heritage, Waterfront and Harbour and Parks and Open Spaces.

The Port Dover Enhancement Association is a not for profit association designed to promote town enhancement initiatives. The Association has published "By Laws" and is currently comprised of eight Executive Members and five Sub Committees. Each of the Sub-Committees has a Chairperson or a Project Lead and associated members where required. The Sub-Committees developed a Mission Statement with Goals and Objectives, which were reviewed by the Executive Board of Directors to ensure that they are appropriate in supporting the overall Mission Statement of the Association.

The Port Dover Enhancement Association is not intended to replace or insinuate itself on any existing Service Clubs or Festivals already contributing to efforts to improve Port Dover. In this regard, an initiative was undertaken to develop a "matrix" which identifies all Service Clubs, Organizations and Festivals along with their contact persons. This will help to better understand the resources that may be available to the Port Dover Enhancement Association as well as eliminating any redundancies or duplication of effort.

In the case where efforts to improve Port Dover by another agency and/or festival are already underway, the Port Dover Enhancement Association could be made available to augment these initiatives through the provision of its resources. Increased efforts to communicate between these various clubs and organizations are essential in maximizing all enhancement efforts in Port Dover.

For the purposes of this plan, the business and economic development areas relating to Port Dover will remain in the periphery and not be explored other than to suggest, were warranted, possible studies that might or should be considered. See Community Improvement Plan & Waterfront Master Plan and the Norfolk County Official Plan.

Port Dover Enhancement Association - Goals

- 1. Completion of the Downtown Enhancements scheduled for completion by July 1, 2011. (Now changed to Nov 30, 2011)
- 2. Orient new Board members to the organisation, to determine their areas of interest and to select an executive. (Completed)
- 3. Review the Mission Statement of the PDEA. (Completed)
- 4. Review our goals and objectives to determine what of those goals and objectives have been completed and what is outstanding and to decide what changes may be required. (Ongoing)
- 5. Review the existing structure of the organisation and determine whether modification may be required. (ongoing)
- 6. Strategize around how to involve those of the existing membership more fully in the organisation. This includes an inventory of their skill sets.
- 7. Continue to liaise with appropriate agencies in order to suggest and implement the Association's enhancement goals and objectives for the Port Dover Community. Review the matrix see App. B (last rev. April 2009)
- 8. Continue to investigate funding for the implementation of developed projects.

It is suggested that, where possible, the above noted Goals be complemented with associated Objectives. In this way it is easier to track the progress of various Goals in an iterative manner.

- Develop and review with the Association, a set of guidelines, which outline and clearly articulate the expectations of the County in terms of parks and open spaces in Port Dover as well as recreational and leisure activities associated with them. <u>These guidelines could be created in conjunction with other initiatives undertaken by the Port Dover Enhancement Committee where appropriate and will incorporate the newly developed "Norfolk County Trails Master Plan".</u>

Appendix A

Port Dover Enhancement Association

Incorporated 2009

By-Laws

Article 1. - Name and Object

Section 1.

The name of this organization shall be the Port Dover Enhancement Association.

Section 2.

The object of the Port Dover Enhancement Association shall be to encourage the preservation and enhancement of the unique identity of Port Dover, as the community develops.

Section 3.

The usual place of meeting shall be in the town of Port Dover.

Section 4.

The Port Dover Enhancement Association shall be non-partisan and non-sectarian and shall not lend its support to any candidate for public office.

Article 2. - Interpretation

Section 5.

Wherever the word "Directors" occur in these By-laws they shall be understood to mean the Directors of the Port Dover Enhancement Association. Wherever the words "the Association" occur in these By-laws they shall be understood to mean the Port Dover Enhancement Association.

Article 3. - Membership

Section 6.

Any person interested in Port Dover and district shall be eligible for membership in the Port Dover Enhancement Association. Section 7.

Associations, Corporations, Societies, Partnerships or Estates may become members of the Port Dover Enhancement Association. If more than one person from any one of these organizations attends a meeting, only one vote per membership will be accepted as designated by the member organization.

Section 8.

Upon registering and after payment of annual dues such person or organization shall be a member of the Port Dover Enhancement Association and shall have all the rights and be subject to all the obligations of the other members. Section 9.

Membership shall continue from the time of admittance until the following annual meeting at which time membership dues for the following year will be collected. Each year, the Directors shall determine the amount of the annual dues. A member may resign or can be removed from the roll of members by action of the Directors in accordance with the provisions of these By-laws. Section 10.

The Directors may remove from the roll of members the names of any new member failing to pay his annual dues within thirty days of his admission, or of any other member who fails to pay such dues within three months of the date they fall due. Upon such action by the Directors, all privileges of membership shall be forfeited.

Section 11.

Persons who have distinguished themselves by some meritorious or public service may be elected Honorary Members by a majority vote of the Directors. Honorary Membership shall include all the privileges of active membership except that of holding office, with exemption from the payment of annual dues.

Article 4

Meetings of the Port Dover Enhancement Association

Section 12

Meetings of the Association members shall be held at least twice per year to hear reports, provide input and to stay abreast of developments at a time and place designated by the Directors.

Article 5. – Committees

Section 13.

Committees will be established by the Directors to accomplish the objectives of the Port Dover Enhancement Association. Members of the committees will normally be members of the Association. Committees make recommendations to the Directors for approval before action is taken or money is expended. Committee chairs submit reports and recommendations to the Directors through the Secretary.

Article 6. - Board of Directors

Section 14.

Four members shall be elected by ballot from among the eligible members each year at the annual general meeting and shall become Directors. They shall remain in office for two years or until their successors shall be appointed. Together with the four Directors serving year two of their term, the eight Directors shall, each year, choose a Chair, Vice-Chair, Secretary, and Treasurer to be the Executive. A retiring Chair, if not returned as a Director, shall be a voting ex-officio member of the Directors until the next annual meeting.

Section 15.

Any vacancy on the Directors which may occur during the year shall be filled by the Directors with that appointment being for the balance of the term of the replaced director.

Section 16.

If a director misses three meetings without arranging for a leave of absence, he/she will be replaced.

Section 17.

Five Directors shall be a quorum and a majority of such quorum may do all things within the powers of the Directors. The Directors shall meet at least eight times per year, as called by the Chair. Directors may be present at a meeting by conference call or other technology which permits two-way audio, uninterrupted participation in real time.

Section 18.

The Directors shall have the general power of administration. They may appoint committees or designate members of the Directors or of the Association, or others, to examine, consider and report upon any matter or take such action as the Directors may request. The Directors may obtain funding, hire staff.

Section 19.

No public pronouncement in the name of the Association may be made unless authorized by the Directors or by some person to whom the Directors have delegated this authority.

Section 20.

The Chair shall preside at all meetings of the Association and Directors. He/she shall regulate the order of business at such meetings, receive and put lawful motions and communicate to the meeting what he/she may think may concern the Association. He/she will be an ex-officio member of each committee, being advised of all meetings and receiving all correspondence. Section 21.

The Vice Chair shall act in the absence of the Chair and in the absence of both of these officers the meeting shall appoint a chair to act temporarily. This appointment shall be from the Directors.

Section 22.

The Treasurer shall have charge of all funds of the Association and shall deposit the same in a chartered Bank, selected by the Directors. Out of such funds he/she shall pay amounts approved by the Directors and shall keep a regular account of the income and expenditures of the Association. He/she will maintain the membership list in good standing. Section 23.

The Secretary shall be the executive officer of the Association and shall be responsible to the Directors for the general control and management of business and affairs. He/she shall be responsible for the correspondence and records of the Association, preserving all official documents and shall perform all such other duties as properly appertain to this office. At the expiration of the term of office, the Secretary shall deliver to the Association all books, papers and other property of the Association.

Article 8. - Conflict of Interest

Section 24.

Members must declare any conflict of interest and remove themselves from the discussion and voting. A conflict of interest is defined as one in which a person has a real or perceived interest in a decision to be taken.

Article 9. - Affiliation

Section 25.

The Association, at the discretion of the Directors, shall have power to affiliate with any other organization in which membership may be in the interest of the Association.

Article 10. - Fiscal Year

Section 26.

The fiscal year of the Association shall commence on September 1 in each year.

Section 27.

An annual meeting will be held within 3 months of the year end at a time and place designated by the Directors to report on the previous year's activities and finances, to elect new Directors and to appoint an auditor. At any annual meeting, ten members shall be a quorum with a simple majority of members present required to pass a motion.

Article 10. - Auditors

Section 28.

The Directors, lawfully met, shall determine each year the level of scrutiny required of the annual statements and related accounting records by the auditor. The auditor shall be independent of the Directors with a level of professional certification to the extent the Directors consider necessary. A financial statement shall be presented by the Treasurer at each annual meeting.
